COUNTER-AFFIDAVIT

1. FERDINAND (a.k.a. "YHONG") H. NAVARRO, of legal age, Filipino, single with address c/o 6th Floor, Citibank Center, Paseo de Roxas, Makati City, after having sworn to in accordance with law depose and say, hat:

1. I am accused by one **NAME WITHHELD** ("the complainant") of having committed the crime of rape against her sometime in early 2009¹. The rape supposedly occurred inside my SUV with lots of other people around outside.

2. I categorically deny the accusation that I raped the complainant in "early 2009", supposedly inside my SUV "with lots of other people around outside". I did not ask my driver to tell complainant to go inside my car. I did not do the things she accuses of doing to her inside the vehicle. I did not rape her.

3. I recall working with the complainant in the television show "Love Betty La Fea" ("Telenovela") in 2009 where, as she says, she worked as Bea Alonzo's stunt double. What I recall is that the complainant was a medium build with a height of around 5 feet 7 inches. I also recall that it was physically fit which would have been necessary in her work as a stunt double.

4. Significantly, the complainant asserts the rape occurred in "early 2009". Her refusal or inability to be more specific about when it supposedly "painful and humiliating experience" happened raises question about the credibility of the claim. In fact, according to reports, the first episode of the Telenovela was shown on April 24, 2009. The last few weeks of tapings for the Telenovela would thus have been sometime in April 2009 which would not normally be characterized as "early 2009."

5. More importantly, the complaint is an unsubstantiated fabrication. It must be dismissed outright for being incredible, for failing to adequately and credibly demonstrate or explain the use of force as an element of the act allegedly committed by me upon the complainant, and it being clear – by its unnecessary allegation of false details, especially relating to physical attributes – that the complaint was brought only for the purpose of shaming, harassing, degrading, and humiliating me.

The following circumstances support the dismissal of the complaint:

4. First, the event happened more than 5 years ago. This casts doubt on the credibility of the charge itself.
